Tot Lot HC 11 and HC 12 Renovation – Denis Ellis presented the renovation design for HC 11 tot lot on Endymion Way. Three residents were present who presented a petition from their neighbors to remove the Endymion Tot Lot because it is no longer used. It was also suggested that that tot lot be closed at dusk.

Mr. Ellis then presented the renovation plans for tot lot HC 12 on Evangeline Way. The Board requested that the sandbox be removed and that swings be added. Mr. Ellis will re-design the tot lot and meet with the Board at a later date.

**Ms. DeLacy moved to request CA to close the Endymion Way Tot Lot (HC11) at dusk.  
Ms. Brooks seconded: all in favor.**

**Ms. DeLacy moved to request that the Board begin the process to ask CA to close Endymion Way Tot Lot (HC 11) as on May 1 2011. Mr. Smith seconded; all in favor.**

HCVCCP Charter – Ms. Tzucker presented the charter for the Harper's Choice Village Center Community Plan charter. **Ms. Brooks moved to approve the Charter with the**

**amendment to include review by the Architectural Committee. Ms. DeLacy seconded; all in favor.**

**The Board moved to go into Executive Session at 9:05 to discuss Personal matters.**
