- A. - B. Request for Juanita Robinson Grant Funds – Lori Jenner and Megan Friedman, Longfellow Elementary School, submitted a written request for a grant in the amount of \$720.50 to help with the purchase of materials needed to create and implement the Longfellow Pantry. **Ms. Procida moved and it was seconded by Mr. Cook to approve a grant in the amount of \$250. Ms. Procida moved to withdraw her motion and it was seconded by Mr. Cook. Ms. Procida moved and it was seconded by Mr. Smith to request that Ms. Jenner and/or Ms.**

**Friedman come before the board to present their request in person and to answer questions about the request. Motion passed unanimously.**
